4a (Code:) (Expenses \$ 1,166,552 including grants of \$ 0) (Revenue \$ 0) Collections - Lending of books, magazines, DVDs and other resources to the Library's 138,163 cardholders, is one of the primary services offered by the Library. In 2020, Library users borrowed approximately 607,068 items. Of this total, adult and children's resource items were borrowed 595,784 and 445,845 times, respectively. In addition, the Library saw 494,859 online resource items searched and 214,677 e-books loaned during 2020.

4b (Code:) (Expenses \$ 908,695 including grants of \$ 33,333) (Revenue \$ 340) Programming and Outreach - Programs for families and children are a core Library service. The in-library and outreach programs are designed to encourage children to associate fun with learning and reading. In 2020, The Library had 1,555 programs and outreach visits with 23,638 attendees throughout the year. In addition to events, programming included the annual summer reading program, designed to keep children and adults actively engaged in reading and learning over the summer, early learning programs focused on math and science, movement, and art, Born to Read, which is designed to encourage early learning by introducing new parents to reading with their baby, and many others.

4c (Code:) (Expenses \$ 765,408 including grants of \$ 40,000) (Revenue \$ 0) Public Computing - Free access to the internet and public computing is another core service provided by The Library. In 2020 The Library offered 160 public use computers (PC's and laptops), however, starting in late March only 81 were available for use, which were used 43,781 times by library visitors during 11,938 public hours. In addition, library cardholders performed 2 million searches of library catalog. The Library had over 358,000 sessions of Wi-Fi used in 2020.

Form 990, Part VI, Section A, Line 7a - The Board of Trustees is comprised of 17 members. 12 members are elected to a three-year term by the governing body. The remaining 5 members are appointed for a three-year term by the Dauphin County Commissioners. These appointments are staggered so that the appointees are divided into three classes of equal distribution. This ensures that no more than one-third (1/3) of the Trustees are elected in any given year.

Form 990, Part VI, Section B, Line 11b - The 990 review process is as follows. The Finance Director prepares the 990 after the audit of the financial statements is complete. The draft 990 is presented to the Finance and Executive Committees of the Board of Trustees and the Executive Director. After obtaining the approval of these Committees, the draft 990 is presented to the full Board of Trustees with the Finance Committee making a recommendation to the Board for approval. Once all questions have been satisfactorily answered and the Board approves the 990, it is filed with the Internal Revenue Service.

Form 990, Part VI, Section B, Line 12c - Each January, the Executive Committee reviews the Conflict of Interest policy. Any necessary revisions are made at that time. The policy is then presented and reviewed at the January Board of Trustees meeting. All Trustees, the Executive Director and the Finance Director, are required to sign and return a copy of the policy and provide details of known conflicts. Each is given a copy of their records. The Finance Director collects the signed documents which are retained in the System files. For the calendar year 2020, all Trustees submitted a signed copy of the policy and provided details of any known conflicts.

Form 990, Part VI, Section B, Line 15 - The Personnel Committee of the Board of Trustees along with the Human Resources and Finance Directors, conducts an analysis of salary and benefits for the organization. Primary focus is placed on senior staff in the review with the Committee. Wage and benefit data is gathered from various sources including surveys of not-for-profit organizations in Pennsylvania as well as other not-for-profits in the eastern United States and other Library Associations. The compensation of the Executive Director is determined by the Board of Trustees. The Finance Director's salary is set along with the other organizational staff.

The 990 and audited financial statements are also available on the Library's website. The Library includes annual financial information in various mailings to donors throughout the year.
